<sup>4</sup> Based on UC’s Bylaws, it appears that a UC employee can be classified as a mix of “tenure” and “non-tenure.” But, in order to be a member of the Senate, the employee must be 50% or more “tenure.” So that if, for example, a UC Professor is classified only 40% tenure, then—although having the title of Professor—this employee will not be a member of the Faculty Senate. It is uncertain what the 50% represents.
