#### III. Policy

#### A. University of Utah

#### 1. Authority

a. The University of Utah is an institution of higher learning organized under the constitution and laws of the state of Utah as a body corporate and politic, controlled and supported by the people of the state, and dedicated primarily to disseminating and assimilating knowledge in advanced fields of study and higher learning, research, and intellectual service to the state and nation. The University is granted authority by the state as listed in Utah Code Sections 53B-2-101 and 53B-1-102, Utah Code Title 53B, Chapter 17, University of Utah and other laws as applicable.

## 2. Operation

a. The University is granted responsibility for institutional operation as defined in the Utah Board of Higher Education Policy R121-3.

#### B. Utah Board of Higher Education

- 1. Authority and Functions
  - a. The Utah Board of Higher Education is empowered as a single board by the legislature to govern the Utah System of Higher Education, of which the University of Utah is a member, and to centrally direct and plan the course of higher education in Utah, delegating powers to the boards of trustees of members of the Utah system of higher education at its discretion. Utah Code Section 53B-1-402, Utah Board of Higher Education Policies R120-3.1 and R121
  - b. The authority of the Utah Board of Higher Education to organize committees is established in Utah Code 53B-1-404 and Utah Board of Higher Education Policy R120.
- 2. Elections and Duties of the Officers of the Utah Board of Higher Education are established as listed in Utah Board of Higher Education Policy R120.
- 3. Commissioner of Higher Education

- a. The appointment of and succession plan for the Commissioner of Higher Education are established in Utah Code Section 53B-1-408 and Utah Board of Higher Education Policies R143 and R121.
- b. The duties and responsibilities of the Commissioner of Higher Education are established in Utah Code Section 53B-1-408 and Utah Board of Higher Education Policy R141.

Sections IV- VII are for user information and are not subject to the approval of the Academic Senate or the Board of Trustees. The Institutional Policy Committee, the Policy Owner, or the Policy Officer may update these sections at any time.
